## PROPOSED GERS TERMINATION AMENDMENT AND REESTABLISHED GERS

Miss Munson began by explaining how this version of the Reestablished GERS was developed. She said that a number of Trustees had concerns about the number of revisions which the City had proposed originally. She said the committee drafted this version using the current GERS Ordinance as the starting point and adding the changes that all the parties had agreed upon such as corrections to reflect past action by the City Council and changes recommended by the Board in the April 2019 memo to City Council, etc. Also included in this version are changes which the City suggested such as adding a table of contents and capitalizing proper terms, etc. Although the Board does not have authority to approve the Reestablished GERS, the committee would recommend that the Board deem this version acceptable since the City Council will likely consider the Board's position when it is before them after IRS approval.

Ms. Kopacz indicated that some of the proposed revisions were substantive and wanted to discuss the revisions made to Sections 3, 4, 6, 7, 9, 10, 11, 20, 28 and 40.
