not have a relationship with him.

Ms. Billings-Dunn explained that at the last meeting she was not aware of a rule that we needed to sign an acknowledgment of the disclosure, and Brian Monroe has since then provided SCC rule where they

need that to show that they have disclosed and provided the required information under the SCC rule.

That disclosure does not bind the System to the third-party marketer.

Trustee Moore stated that he has no issue with the disclosure and that his question was why that was on

the transfer document.

Ms. Billings-Dunn stated that there were two documents: the transfer document and the disclosure

document which shows they have a third-party marketer. She explained that under SCC rules they are

required to prove that they had disclosed it.

Chairman Albritton stated that them being transparent does not change anything from the Board's perspective. He thinks that they were being cautious and being transparent with the third-party marketer.

He does not think it should hold up any signatures to move forward with the new GERS.

The vote was taken again.
